16. Certificate of Ownership (this includes seabed)

Plans for alteration or extensions to existing sites should show both existing and proposed equipment, clearly indicating existing and proposed equipment. The site plan should also give a 6-figure Ordnance Survey grid reference for the center of the site along with the latitude/longitude positions of the external corners or edges.
  - Plans, and sections of all equipment (primary and ancillary). Shall be submitted as part of the application these should be at a scale of no less than 1:100 and provided full and accurate details of all equipment (cages/cultivating equipment, moorings and all ancillary equipment)
- Photographs and/or photomontages: These can provide a useful aid to the planning process particularly in visually sensitive sites. However, they are not required in all instances. Where the local authority has specified a need for them (e.g. in a scoping opinion) its requirements must be met.
